# Happy Hearts Payment Authorization

All Happy Hearts participants are required to have a JCC account to enable automatic monthly credit card payments. If you do not already have a JCC account, please visit [jccgv.com](http://jccgv.com) to create one and add your payment information.

Participants will be billed at the time of initial registration for the current month and then monthly thereafter. Monthly fees are charged between the 23rd and 26th of the month prior to the upcoming month. If a participant joins after the second class of the month, the monthly fee will be prorated.

By providing your credit card information, you authorize the JCC to charge your card automatically each month on an ongoing basis. The Happy Hearts program operates as a continuous program.

A minimum of 30 days' written notice is required to cancel or freeze payments.

If the monthly rate changes, you will receive at least 30 days' notice and will have the option to cancel your ongoing enrollment at that time.
